TUESDAY, NOVEMBER 8, 2022

TO THE QUALIFIED ELECTORS OF ARENAC COUNTY MICHIGAN:

PLEASE TAKE NOTICE that any qualified elector of Arenac County, Michigan who is not already registered, may register to vote at the Office of their respective City or Township Clerk, the office of the County Clerk, a Secretary of State branch office or other designated state agency. Registration forms may be obtained at MI.gov/vote and mailed to the office of your respective Township or City Clerk. Voters who are already registered may update their registration at www.expressSOS.com.

The last day to register in any manner other than in-person with the local clerk is **MONDAY, OCTOBER 24, 2022**.

After this date, anyone who qualifies as an elector may register to vote in person with proof of residency (MCL 168.492) at their respective City or Township Clerk's office with contact information listed below. Voters need to contact respective City or Township Clerk to ascertain hours of availability. Contact Information as listed below is also posted at the respective City or Township Hall.

STATE PROPOSALS:

Proposal 22-1

Legislative term limits and financial disclosure

A proposal to amend the state constitution to require annual public financial disclosure reports by legislators and other state officers and change state legislator term limit to 12 total years in legislature.

This proposed constitutional amendment would:

- Require members of legislature, governor, lieutenant governor, secretary of state, and attorney general file annual public financial disclosure reports after 2023, including assets, liabilities, income sources, future employment agreements, gifts, travel reimbursements, and positions held in organizations except religious, social, and political organizations.
- Require legislature implement but not limit or restrict reporting requirements.
- Replace current term limits for state representatives and state senators with a 12-year total limit in any combination between house and senate, except a person elected to senate in 2022 may be elected the number of times allowed when that person became a candidate.

Proposal 22-2

Voting policies amendment

A proposal to amend the state constitution to add provisions regarding elections.

This proposed constitutional amendment would:

- Recognize fundamental right to vote without harassing conduct;
- Require military or overseas ballots be counted if postmarked by election day;
- Provide voter right to verify identity with photo ID or signed statement;
- Provide voter right to single application to vote absentee in all elections;
- Require state-funded absentee-ballot drop boxes, and postage for absentee applications and ballots;
- Provide that only election officials may conduct post-election audits;
- Require nine days of early in-person voting;
- Allow donations to fund elections, which must be disclosed;
- Require canvass boards certify election results based only on the official records of votes cast.

Proposal 22-3

Right to reproductive freedom

A proposal to amend the state constitution to establish new individual right to reproductive freedom, including right to make all decisions about pregnancy and abortion; allow state to regulate abortion in some cases; and forbid prosecution of individuals exercising established right

This proposed constitutional amendment would:

- Establish new individual right to reproductive freedom, including right to make and carry out all decisions about pregnancy, such as prenatal care, childbirth, postpartum care, contraception, sterilization, abortion, miscarriage management, and infertility;
- Allow state to regulate abortion after fetal viability, but not prohibit if medically needed to protect a patient's life or physical or mental health;
- Forbid state discrimination in enforcement of this right; prohibit prosecution of an individual, or a person helping a pregnant individual, for exercising rights established by this amendment;
- Invalidate state laws conflicting with this amendment.

COUNTY PROPOSAL

Proposal #1 COUNTY VETERANS SERVICES PROGRAM MILLAGE PROPOSAL

For the sole purpose of funding Arenac County's obligation to provide financial relief and service for Arenac County Veterans, to fund the administration, services and financial aid to veterans of Arenac County; shall the constitutional limitation on General Ad Valorem which may be assessed in any one (1) year upon all property within the County of Arenac as provided in Article IX, Section 6, of the Michigan Constitution be established and the Arenac County Board of Commissioners be authorized to levy a tax of 1/10th mill per \$1,000 of taxable value for the period of two (2) years beginning in 2022 (2022 & 2023)?

If approved and levied in full this mileage will raise an estimated \$65,465 in the first calendar year for Veteran's services.

CITY PROPOSAL:

City of Omer Proposal for Mosquito Control

Shall the tax limitation under Article IX, Sec. 6 of the Michigan Constitution on General Ad Valorem Taxes within the City of Omer, County of Arenac, and State of Michigan be assessed on all real property within the City of Omer for a period of two years (2023-2024 inclusive). This assessment will allow the City of Omer to levy a \$45.00 (forty-five dollars) property tax assessment, for the purpose of providing Mosquito Control?

If levied, this special assessment would raise approximately twelve thousand, seven hundred, and thirty five dollars (\$12,735.00) in the first year.
