BE IT RESOLVED that Arenac County shall not discriminate in the sale, rental, leasing, or financing of housing because of religion, race, color, gender, physical or mental disabilities, national origin, age, height, weight, familial status, or marital status;

Arenac County will at a minimum post this policy or the Fair Housing poster or other posters flyers or other information which will bring to the attention of owners of real estate developers and builders their respective responsibilities and rights under the Federal Fair Housing Law and Michigan Elliott Larsen Act.

Motion #7: Courthouse Security & Camera Project:

After discussion with Edward Rohn, County Emergency Management Coordinator, it was moved by Mrs. Luce & 2nd by Mrs. Zygiel to approve the proposed project plan through the Michigan Municipal Risk Management Authority Grant RAP Program with a total project cost of about \$10,000 with 50% reimbursement from the program and to authorize the Board Chair to sign the Grant application. Motion was carried, and Mr. Rohn noted that paperwork will be submitted for the Grant.

Commissioner Reports:

Mr. Snyder noted that he has had conversation with Judge Vollbach regarding Wi-Fi in the Building and that there will be two terminal locations, Probate Court and District Court with services outside of the Court Computer System and it will be paid with 2% monies funded through the Courts & County.

Mrs. Zygiel reported that she has received from the Sunrise Senior Services (Council on Aging) in Omer, a report including their audit for the last fiscal year and it is available for viewing.

Mr. Trombley reported that he wishes to be replaced as the MSU E representative/contact and suggested that Mr. Luce be his replacement on this assignment. After further discussion, it was noted that all serve at the wishes of the Chair and Mr. Munson noted he had no issue with Mr. Luce assuming said duties.

Mr. Trombley also, with other Commissioners, discussed other MSU E focus for the future as well as it was noted that their staffing has been reduced dramatically over the past few years.

The Commissioners further discussed the Winter Michigan Association of Counties Legislative Conference and Mr. Luce noted an interest in attendance. It was agreed any member could attend if they so wished to attend the Conference. He noted he would sign up via County Clerk's Office after the Board Meeting today.

Commissioners further discussed a possible meeting with FEMA in Chicago regarding Flood Plain Maps and possible attendance at a meeting with them in Chicago. No action was taken at this time.

Commissioners further discussed a possible intergovernmental agreement for a cooperative effort with the City of Standish regarding a possible 2% Community/Area Study for the area of Cedar Street east of M-61.

Page # 6: Arenac County Board of Commissioner's Meeting of January 21, 2014:

This conversation was brought about because of amount of vacant business buildings as well as the impending closure of Norman's and the Deeding of the Independent Properties to the City of Standish as well as a number of other vacant parcels.

The completion of the Jail Boiler Project was further discussed noting that we are awaiting final project clearance regarding the project and that the County Treasurer is waiting on possible Consumers Energy Grant reimbursement. (This must be done by end of March 2014 to receive any grant dollars).

Mr. Snyder also reported that the February Inter-governmental Cooperation Memo for the dashboard has been submitted to the State of Michigan to meet deadline and the project was discussed.

Chair David Munson called the regular meeting of the Arenac County Board of Commissioners to order at 1:30 P.M. pursuant to the Michigan Open Meetings Act and Public Notice.

Approval of an Agenda:

It was moved by Mrs. Zygiel & 2nd by Mr. Trombley to approve the proposed agenda as distributed. Motion carried.

Approval of Various Minutes:

Committee of the Whole of February 4, 2014: It was moved by Mr. Luce & 2nd by Mrs. Zygiel to approve the minutes of the meeting as distributed. Motion was carried.

Board Session Minutes of February 4, 2014: It was moved by Mr. Luce & 2nd by Mr. Trombley to approve the minutes of the Board Session of February 4, 2018. The motion was carried.

Claims & Accounts:

Public Comments:

Mr. Floyd Bender, Standish Township Resident commented on recent Lighting District Special Assessments in the Township and questioned Commissioners regarding his concerns that the billing amount was not sufficient for the Township of Standish to be able to pay the billings to Consumers Energy. After further discussion, it was noted that the Township Board may appropriate funds toward payment of bills regarding, but cannot use Special Assessment Funds for any other purpose, Clerk using County held funds as an example of transfers within the Arenac County General Bank, noting that any transfer of funds must be approved by the governing body. It was further noted that the Equalization Department only places the amounts on the tax rolls as requested by the Local Unit or Other Taxing Authority.

There were no further public comments.

Unfinished Business:

The Board and County Clerk discussed Various Millage issues that may appear on the August and November 2014 Ballots. It was noted that the Senior Millage of .75 mill expires this year 2014 and likewise, the .50 mill Ambulance Millage so expires this year. Also up for consideration are several other items including a possible Fixed Millage Proposal. Mrs. Zygiel will contact Sunrise Seniors about their proposal. Mr. Snyder will contact Mobile Medical Response regarding Ambulance Millage renewal and Mrs. Zygiel as a member of the Tax Allocation Board will return with information regarding a Fixed Millage Proposal for the County and Townships. Discussion ended. It was noted deadline for approval is in the early part of May to appear on the August 5, 2014 Primary Election Ballot.

Public Comments:

Mr. Glen Rice, Arenac Township Resident: Questioned as to why the Arenac County Soil Conservation District does NOT receive an annual appropriation. After some discussion, it was noted that many years ago, the Soil Conservation District did indeed receive an annual appropriation in the Arenac County General Fund Budget as well as other agencies such as the District Library, Senior Citizen Programs and the like before they had other millage available to them.

The projected costs will be less than we are currently paying for per copy in some machines and will eliminate fax machines, toner purchases, and be full service copiers like several of the current larger copiers in the building.

The Board directed the Clerk to return to a subsequent meeting with a proposal for that office to begin the process.

<u>July 9th, 2014</u> <u>Minutes of a Call Session of the County Board of Commissioners:</u>

Chair David Munson called this special Session of the Arenac County Board of Commissioners to order pursuant to Chair request and to solve any issues relating to the "In Home Care Juvenile Budget" and related compensation to employees involved in the program.

The Board recited the Pledge of Allegiance to the U. S. Flag and it was noted that today's session was pursuant to call with public notice being posted and members contacted and for purposes related to above mentioned program only.

Members Present: Michael Snyder, Jeffrey Trombley, David Munson, & Virginia Zygiel. Absent: Robert Luce (escused).

Also in attendance: William P. Borushko, Employment Relations Advisors; County Clerk Rick Rockwell, Judge of Probate, Hon. Richard Vollbach, Cristy Slocum, Circuit Court Administrator, June Baker, Register of Probate, Jeffrey Ryan, Juvenile Officer. Dennis Stawowy, Arenac County Treasurer.

Public Comments: None.

Presentation of Information from Judge Vollbach:

Chair requested that Judge Vollbach make a presentation regarding the "In Home Care Juvenile Program". Judge Vollbach reviewed the bound packet presented on May 6rth and noted the Cost Study that was performed and he explained the "benefits" to Arenac County of the Program including necessary pay increases to cover additional duties for staff listed in the minutes of the Committee of the Whole of Board of Commissioners. He also discussed the reclassification of workers whose wages will be readjusted as well as it was agreed to allow the Judge to continue his presentation without interruption and questions to be addressed at the end. There was some discussion regarding whether this was a Plan or Grant and it was agreed that it was indeed part of "Plan". He noted that the Board authorized it's presiding officer to sign said plan and made a motion to accept the "Plan" and the "In Home Care Budget" was indeed submitted with Board Signature and blessing by motion. He further noted that the State of Michigan then approved the plan within a few days. He further noted that the State of Michigan sent a letter to the "Board of Commissioner's Office mailbox and a copy to his office dated June 4, 2014 addressed to the Board Vice-Chair. He then further noted no contact from the Board or their representatives until July 8th, 2014; being this week. He further discussed the reasons for the "Plan" and the "Benefits" to the County of Arenac of participating in an "Intensive Care Juvenile In Home Program" and redirecting employee efforts regarding administrative savings of having current staff handle the program. He believes that the program will save the County about \$30-\$50 K per year and in addition, reduce Child Care Institutional Costs. He further noted that all other counties in our Circuit have added additional employees as full time positions to handle the program.

Commissioners and the Judge at this point discussed the various issues regarding the "Plan". Included was a discussion of what the other Counties in the Circuit are doing regarding these matters and what typical pay rates are at this time and the relative functions of the so stated positions mentioned.

Cristy Slocum, Circuit Court Administrator, discussed various aspects of the program as well as why the dollar figures were arrived at and compared positions in relative Counties and discussed reporting of the program as well as reports necessary to be submitted.

Dennis Stawowy, Arenac County Treasurer, commented to the Commissioners regarding his contact with MGT, who prepared the Cost Allocation Plan as well. He further noted his conversation with MGT (Jim) and the explanation they gave regarding the program as well as noting that MGT presented the program to the Board in Committee and he personally feels that the Program will be financially beneficial to Arenac County and its Citizens.

Jeffrey Ryan, County Juvenile Officer, also discussed certain aspects of the program to the Commissioners including specifics regarding the program.

William P. Borushko, Employment Relations Advisors, discussed certain issues and asked questions as well as reviewed documents with Commissioners, some of which, the Board had requested regarding the program

There were no other comments at this time.

The Chair requested an opinion from Mr. Borushko as to his suggestion as to the direction the County Commissioners should take. Mr. Borushko suggested to the Board that they approve the proposed program noting that he an Judge Vollbach have both discussed it prior to this date and he recommended that the Board amend their salaries resolution effective July 1, 2014 to reflect the salary adjustments proposed.

Motion regarding "In Home Care Program & Related":

#1: The County has decided it is cost effective to have the auditors prepare the F-65 and the County Contracts with the Auditors.

#2: Central Management of all Grant Documents in one location. Not all departments are complying with this issue.

#3: Drain Maintenance Levies Cash Ledger. Total cash balance is known but balance in individual drains not known.

#4: County needs a procurement policy that meets federal standards for grants.

#5: Monitoring of Invoices from Third Party Vendors (Housing Related) need to occur and there are outstanding issues with Housing Programs that are not yet cleared up with MSHDA.

Page # 2: Arenac County Commissioners' Minutes of July 15th, 2014:

#6: Inmate Trust Account. Inmate trust bank account does not reconcile to the County's General Ledger. Also Sheriff or Undersheriff should carefully review activity in the jail accounts and that same should be reconciled monthly, with a copy to the County Treasurer.

#7: Budget Preparation and Control. Need to make sure Budget Fund Balance does not place any fund into a deficit situation. More frequent review of this is necessary.

Corrected Findings in 2013:

- 1. Board Review of Cancelled Checks.
- 2. Board review and approval of pre-authorized disbursements.
- 3. Written Documentation for Payroll changes.
- 4. Inter-fund Borrowing.

The Auditor and Board discussed the year end fund balance at 7% noting that they like to see a balance of 14-20% minimum and suggest the Board work toward said goal. It was further noted that the year end cash general fund balance was \$311,000 for the General Fund, a decrease from \$382,000 the prior year, mostly due to lower than anticipated tax revenues versus the budget figures as well as charges for services being approximately \$68,000 lower than anticipated.

Also in the letter, it was noted that the County received an unqualified opinion, which is the best opinion from the auditor that can be received. She further said that the above seven bullet items need continual monitoring and resolution as best as is possible and thanked the Board for their participation and suggested they continue their best efforts to resolve any issues and encouraged commissioners to make sure that budgets are prepared so that there will be no deficits as well as to make periodic adjustments when line items are in deficiencies.

The Chair thanked Ms. Carruthers and declared a recess to allow those present from "211" time to set up their presentation which is scheduled for 3 PM.

211 Presentation:

Several Persons were in attendance to present data regarding the 211 Program and noting that there were over 1300 calls to it in 2013 and they shared a handout to share statistics regarding the requests and noted that 87% of requests were met. After the presentation, Mr. Frank Cloutier and the Board discussed the possible application for Tribal 2% funds to fund this program for a number of years at \$.15 per capita, which is currently being funded by donations and various county united way agencies in Northeastern Michigan.
