### Resolution No. 2024-08

### Credit Card Policy

Whereas, section 3 of Act 266 of 1995 states that a local unit shall not be a party to a credit card arrangement unless the governing body of the local unit has adopted by resolution a written policy governing the use and administration of credit cards; and

Whereas, such written policy shall provide; (a) That an officer or employee designated by the credit card policy is responsible for the local unit's credit card issuance, accounting, monitoring, and retrieval and generally for overseeing compliance with the credit card policy. (b) That a credit card may be used only by an efficer or employee of the local unit for the purchase of goods or services for the official business of the local unit. In addition, the credit card policy may limit the specific official business for which credit cards may be used. This subdivision does not limit the applicability of chapter XXIVA or section 174, 175, 219a, or 490a of the Michigan penal code, Act No. 328 of the Public Acts of 1931, being sections 750.157m to 750.157w, 750.174, 750.175, 750.219a, and 750.490a of the Michigan Compiled Laws; section Ia of the code of criminal procedure, Act No. 175 of the Public Acts of 1927, being section 769. Ia of the Michigan Compiled Laws; or any other law, or ordinance, applicable to use of a credit card, issued by a local unit, for other than official business of the local unit. (c) That an officer or employee using credit cards issued by the local unit shall submit to the local unit documentation described in the credit card policy detailing the goods or services purchased, the cost of the goods or services, the date of the purchase, and the official business for which purchased. (d) That an officer or employee issued a credit card is responsible for its

protection and custody and shall immediately notify the local unit if the credit card is lost or stolen. (e) That an officer or employee issued a credit card shall return the credit card upon the termination of his or her employment or service in office with the local unit. (f) For a system of internal accounting controls to monitor the use of credit cards issued by the local unit. (g) For the approval of credit card invoices before payment. (h) That the balance including interest due on an extension of credit under the credit card arrangement shall be paid for within not more than 60 days of the initial statement date. The local unit shall comply with this provision of the credit card policy. (i) For disciplinary measures consistent with law for the unauthorized use of a credit card by an officer or employee of the local unit. (j) Any other matters the governing body considers advisable; and

Whereas, all Gasoline credit card purchases including invoices, receipts, and statements, will be handled by the County Clerk's office; and

Whereas, Gasoline credit card transactions will be limited to gasoline and one quart of oil per purchase and a car wash, only, and

Whereas, all Arenae County credit card transactions will be handled by the County Board of Commissioners office, the County Coordinator shall be provided with documentation detailing the goods or services purchased, the cost of the goods or services, the date of the purchase, and the official business for which purchased before the transaction occurs; and

Whereas, Arenac County credit card uses are only authorized for conference reservations, meeting or training registration, office or departmental supplies, or other purposes specifically approved by the Board of Commissioners; and

Whereas, the authorization to utilize the Arenae County credit card service will be the sole domain of the County Board of Commissioners; and

Whereas, credit card invoices shall be approved before payment, and an officer or employee issued a credit card is responsible for its protection and custody and shall immediately notify the Board of Commissioners or the County Coordinator if the credit card is lost or stolen, and any credit card issued to an employee or officer shall be returned to the Board Office in the event of their termination from employment or end of service in office; and

Whereas, the total combined authorized credit limit of all credit cards issued by the County shall not exceed 5% of the total budget of the County for the current fiscal year; and

Whereas, no personal expenditures will be permitted on any of the County credit cards; and

Whereas, any unauthorized use of any County credit cards will result in all costs that are incurred for purchases, be reimbursed by the employee or officer, and shall be subject to disciplinary measures consistent with Federal and State laws.

Therefore Be It Resolved, that the Arenac County Board of Commissioners adopt the above Credit Card Policy.



# ARENAC COUNTY TRAVEL POLICY

EFFECTIVE DATE: March 26, 2024 APPLICATION: All Employees

#### Section I - General

Application - The Arenac County Board of Commissioners has adopted this travel policy to provide direction for all employees pertaining to travel and expense reimbursement.

Interpretation and Enforcement: The Board of Commissioners is responsible for interpretation and enforcement of these regulations as they apply to all County employees. The Board is also responsible for approving travel expenses for Employees.

Responsibility - Compliance with these regulations is the responsibility of the Department Head. The Board of Commissioners or designee thereof shall have the authority to review travel vouchers or to waive, where special circumstances warrant, any regulation or rates herein.

<u>Degree of Care</u> - All Employees and persons traveling on official business are expected to exercise the same care in incurring expenses that a prudent person would exercise if traveling on personal business.

### Section II - Non-County Individuals

Employees will not receive reimbursement for travel expenses incurred by any Non-County individuals.

# Section III - Travel Approval Reimbursement, Cash Advance

Authority for Travel - All travel and training shall be duly authorized and approved by the Department Head and the Board of Commissioners or designee thereof, prior to departure. Sufficient budgeted funds must be available for such travel.

Reimbursement - Direct payment by the Board of Commissioners for hotel and carrier expense is to be arranged whenever possible. Meals and incidental expenses are to be turned in on an expense account form upon returning to work, with receipts.

Cash Advance for Travel - If expenses are expected to exceed \$500, employees may request a travel advance. Arrangements must be started at least one month in advance of travel and require approval of the Board of Commissioners or designee. Within five working days of end

of travel, receipts showing usage of the cash should be itemized and the balance of the advance (if any) returned. If expenses were greater than the advance, reimbursement to the employee will occur on the next check issuing date.

#### Section IV - Lodging and Meals

<u>Schedule of Rates</u> - Reimbursement of expenses are limited to those allowed by the most recent schedule of rates in the Board Rules. This includes rates for lodging, meals, incidental costs, and mileage. Select cities as well as in-state rates are also available. These rates should be followed depending on the travel location.

Lodging is fully reimbursable as long as it is at the lowest offered rate, approved by the Board of Commissioners, and includes applicable documentation.

Lodging Charges for Multiple Occupancy - When a traveler shares hotel or other lodging with a Non-County traveler (spouse, friends, family member, etc.) who received no travel expenses from another source, reimbursement to the traveler shall be at the rate of single occupancy as certified to the hotel on the receipt. If the lodging is shared with a Non-County traveler who is receiving reimbursement for travel, the reimbursement will be on a proportional amount of the bill, based on the number of persons occupying the room.

Lodging - The Board of Commissioners requires paid, original receipts to support all lodging expense claims.

Meals - When a traveler is entitled to a full day's allowance for meals, the amount expended for any particular meal is left to the discretion of the traveler, but the total for all meals in one day shall not exceed the maximum daily allowance as provided by the current Board Rules. Whenever meals are served on planes or included at no additional cost as part of a class, seminar or meeting, regardless of where the gathering is held, the traveler shall not be entitled to any meal allowance for those particular meals. A corresponding deduction should be made from the daily meal allowances based on the allowance for that particular meal. The cost of alcoholic beverages and non-seminar activities are not eligible for reimbursement by the Arenac County Commissioners. The traveler shall not be reimbursed for Non-County travelers (spouse, family member, friends, etc.).

Allowances for individual meals will be based on the following schedule: Breakfast — When travel commences prior to 6:00 a.m. and extends beyond 8:30 a.m. Lunch — When travel commences prior to 11:30 a.m. and extends beyond 2:00 p.m. Dinner — When travel commences prior to 5:30 p.m. and extends beyond 8:00 p.m. Midnight Lunch — Shall be at lunch rate if travel and work extend beyond midnight.

For trips not involving overnight lodging or not included in a seminar/meeting registration fee the total amount claimed for meals cannot exceed the appropriate published rate.

# Section V + Transportation

All travelers should purchase the least expensive accommodations for airplane, train, bus, etc. Persons choosing first class accommodations shall pay the difference between the least expensive rate and the first-class rate.

Use of privately-owned vehicles for official county business may be authorized when the Department Head in conjunction with the Board of Commissioners determine that privately owned vehicle use is consistent with county operational policies.

All motor vehicle travel must be by the most direct travel route. In cases where an individual travels via an indirect route for their own convenience, any extra costs shall be borne by the individual and reimbursement for expenses will be based only on such charges as would have been incurred by a usually traveled route. If travel by the most direct route is not possible because of construction, detour or other legitimate reasons, the claim for additional mileage should be stated on the Board of Commissioners Travel Expense Form.

Charges for gasoline, lubrication, repairs, antifreeze, towage, and other similar expenditures will not be allowed as reimbursable items when privately owned cars are used.

Reimbursement for toll roads, bridges, parking charges, and parking meters are allowed. No receipts are required for toll roads, bridges, and parking meters. Receipts are required for parking garage and parking lot charges.

The Board of Commissioners does not assume liability for damage to personal automobiles used for company business and does not assume liability for deductions or any other uninsured loss to the vehicle. Liability insurance protection will be provided as excess coverage only after the private owner's personal liability insurance limits are exhausted when the vehicle is used for business purposes. Cost of repairs to a vehicle, whether or not they result from the traveler's acts or not, are not reimbursable.

The Board of Commissioners does not pay for parking tickets or moving violations.

### Section VI - Other Expenses

Telephone - Charges are allowed when necessary for official business: Dates, place, and person called and nature of business must be shown on the voucher for all toll calls. One personal daily call not exceeding \$5.00 is allowed while on overnight travel. The most economical rate available should be used when placing telephone calls.

Gratuities - tips for meals shall not exceed 20% of the cost of the meal. Other tips (porters, maid service, and taxis) shall not exceed \$2.00 per service.

Registration Fees - A program, or other supporting literature showing whether or not meals are included in the fee shall be attached if the information is not shown on the registration receipt.
