RESOLUTION FOR AMENDMENT OF THE COUNTY BUILDING PRESERVATION FUND

WHEREAS, the Board of Commissioners for the County of Arenac previously established a local court account, funded by imposition of "local court costs" (Courthouse Preservation Fund, 470 account) from court ordered criminal court cost, and from civil infractions (referred to as "surcharge"), and then conveyed by the Circuit and District courts in this county to the Arenac County Treasurer, to be utilized for special projects and expenses (Resolution 2015-05); and

WHEREAS, the Board of Commissioners for the County of Arenac desires to continue to maintain a fund for local court and building projects and expenses, separate from those funds gethered by the court and applied to the Arenac County general fund, but included as "court costs" imposed by the courts. It is further understood that the courts are no longer permitted to order a fixed sum as "local costs", in addition to general state authorized "court costs", and therefore must include all *court costs* in one order.

NOW, THEREFORE, be it resolved:

That Resolution 2015-05 be amended in that the subject fund may receive, in addition to monies obtained from any other sources the County may from time to time designate, revenues from fines and costs imposed by the 23rd Circuit/81st District Court Arenac divisions as follows:

From those court costs transmitted to the County Treasurer from the Clerk of the District Court, and the Clerk of the Circuit Court, the Treasurer shall transfer ten (10) percent of all "court costs" ordered by the court, for criminal and civil infraction defendants to pay, to the fund previously established as the Building Preservation Fund under Resolution 2015-05, each month, but not less than quarterly, into said fund for local court expenses/project use, and into the previously named Courthouse Preservation Fund, which will now be maintained as the "Special Court Expense and Project Fund (470 account)". Thus, 90% of "court cost" imposed by the courts will transfer to the Arenac County General Fund, and 10% to the (470 account) Court Special Expense/Project Account.
